### Sources for data

Primary data for the calculation of the hazards has preferentially been taken from the official European classification list, 1272/2008 Annex I, as updated to 2018-10-17.

As a second alternative, information was used from reputable international chemical industries, and as a third alternative other available information was used, e.g. material safety data sheets from other suppliers or information from non-profit associations, where reliability of the source was assessed by expert opinion.
